The following notification shall be published in the Andhra Pradesh Gazette: -

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and of all other powers hereunto enabling, the Governor of Andhra Pradesh hereby makes the following amendments to the Special Rules for the Andhra Pradesh Collegiate Education Service issued in G.O.Ms.No.47, Higher Education (CE.I-1) Department, dated: 14.5.2007 and published in the Andhra Pradesh Gazette Notification No.8, dated: 24th May, 2007 at pages 5, 6, 8 & 19, 2008 :-

AMENDMENTS

In the said rules, -

- I. In rule 3, in the Table,
 - (i) In Class-F, against Category-2 Assistant Directors, in column (2) for the works " and Superintendents and Auditors in the Offices of the Regional Joint Directors of Collegiate Education" the words " and Superintendents in the Offices of the Regional Joint Directors of Collegiate Education " shall be substituted.

(ii) In Note-3 for the words "The post of Administrative Officer", the words "The post of Assistant Director and Administrative Officer" shall be substituted.

(iii) After note 10, the following note shall be added namely :-

(11) " Junior Lecturers (Vocational) working in the Department of Intermediate Education in the subject of Accounting and Taxation shall also be considered for recruitment by transfer as Lecturers in Commerce on the basis of combined seniority, subject to fulfillment of qualifications prescribed in these rules "

II. In the Annexure, after note (5) under the Table, the following note shall be added, namely :-

(6) " Notwithstanding anything in note (4), for recruitment by transfer to the post of Lecturer, Government Degree College (Category - 2 of Class - B), Lecturer, Government Oriental College (Category - 2 of Class C), Librarian (Class - D) and Physical Director (Class - E) candidates possessing at-least 55% marks at the Post - Graduate level or equivalent grade of 'B' in the 7 point scale with letter grades O, A, B, C, D, E and F at Master Degree Level in the relevant subject, obtained from the Universities recognized in India, Shall be considered with the following conditions :-

- (i) that they will be given State Pay Scales.
- (ii) That they will be given 5 years time to acquire the additional higher qualification viz. NET / SLET / M.Phil / Ph.D., failing which, they will not earn their future increments.
- (iii) That they will be given U.G.C Pay Scale from the date of acquiring the additional higher qualification, viz., NET / SLET / M.Phil / Ph.D.

2. These orders shall come into force with retrospective effect from 14.5.2007.
