The following notification shall be published in the Andhra Pradesh Gazette: -

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and of all other powers hereunto enabling, the Governor of Andhra Pradesh hereby makes the following amendments to the Andhra Pradesh Collegiate Education Service Rules issued in G.O.Ms.No.47, Higher Education (CE-I-1) Department, dated 14-05-2007 and published in the Andhra Pradesh Gazette Notification No.8, dated 24<sup>th</sup> May, 2007 as subsequently amended from time to time.

2. The amendment hereby made shall be deemed to have come into force with effect from 11-07-2009.

AMENDMENTS

In the said rules, in the Annexure -

- (1) for the existing Note (4), the following shall be substituted namely -

“(4) NET / SLET shall remain the minimum eligibility condition for recruitment and appointment of Lecturers in Government Degree Colleges / Government Oriental Colleges “

Provided, however, that candidates who are or have been awarded Ph.D degree in compliance of the University Grants Commission (minimum standards and procedure for award of Ph.D. Degree) Regulations, 2009 shall be exempted from the requirements of the minimum eligibility condition of NET / SLET for recruitments and appointment of Lecturers in Government Degree Colleges / Government Oriental Colleges”.

- (2) in Note (6) the word “M.Phil” wherever it occurred shall be omitted.
