The Correspondent, of Sri Bhavanarayana Swamy Sanskrit College, Ponnur, Guntur district and K.V.R.K.V.R & M.K.R College, Khajipalem, Guntur district and others filed W.P.No's 15448/2011 and 15260/2011 respectively challenging the action of the respondents in not processing the salary bills of the staff of both the colleges.

In the reference 2nd and 3rd read above, the Hon'ble High Court while disposing both the writ petitions directed the respondents to process the salary bills of the staff of Sri Bhavanarayana Swamy Sanskrit College, Ponnur, Guntur district and the salary bills of K.V.R.K.V.R & M.K.R College, Khajipalem, Guntur district.

In the reference 3rd and 4th read above, the Correspondents, of S.B.S. Sanskrit College, Ponnur and K.V.R.K.V.R & M.K.R College, Khajipalem, Guntur district while enclosing the copies of Court orders requested to give necessary instructions to the RJDCE, Guntur for passing of salary bills of the staff.

Pursuant to the orders of the Hon'ble High Court, under reference 1&2,cited, the Regional Joint Director of Collegiate Education, Guntur is hereby instructed to pass the salary bills of the staff of S.B.S. College, Ponnur and K.V.R.K.V.R & M.K.R College, Khajipalem, Guntur district presented by the Correspondent, immediately without insisting the signatures of the Principals/ In-Charge Principals.

With regard to the observations of the Hon' ble High Court in the said orders that, "When a person is working in the Physical Education Department as Lecturer, he can be a Lecturer within the meaning of Clause (3) of G.O.Ms.No.12 Edn., dated: 10-01-1992. The amendment to the said G.O does not differentiate between a teaching staff and a Lecturer working in the Physical Education Department. Therefore, when a lecturer of P hysical Education department, who,

according to the petitioners is the senior most person in the petitioner institution, was appointed as Principal, Full Additional Charge, of the petitioner institution, he is entitled to sign and process the Salary Bills".

In this connection, the Regional Joint Director of Collegiate Education, Guntur is requested to file an appeal on the above aspect against both the writ petitions as the Physical Directors and Librarians are not eligible for promotion as Principals as per G.O.Ms.No.127 Edn., dated: 07-06-1993 duly consulting the G.P. for Higher Education, High court, Hyderabad immediately and report compliance.
